

T&Cs for CoinSwitch Quiz for India ka top 1%

1. **Bitcipher Labs LLP (“CoinSwitch” / “Us” / “We”)** is offering the opportunity to participate in the program called “India Ke Top 1%- Sirf Degree Nahin Dimaag Bhi Jeetega -!” (“**Program**”) produced by Jiostar India Private Limited (“**Producer**”) by participating in a Quiz (“**Contest**”) as constructed at the sole discretion of CoinSwitch, as per the terms contained herein (“**Terms**”). "You", "Your" or "User" shall be an individual who participates in the Contest. These Terms govern Your participation in the Contest. We reserve the right to amend or suspend the Contest at any time, for any reason without prior notice or any liability to You. The User hereby agrees and acknowledges that upon participating in the Contest, the User shall be bound by these Terms, as updated, modified, and/or replaced from time to time at the sole discretion of CoinSwitch without any prior notice to You. You are advised to review these Terms on website <https://coinswitch.co/india-ke-top-1-percent> for any such amendment, replacement, or changes to the terms contained herein and any future use or access to any services covered herein. Capitalized terms used but not defined herein shall have the meanings given to them in the Standard Terms.
2. **Eligibility:** To participate in the Contest, You must satisfy the following conditions at the time of entry and throughout the Contest Period:
 - A. You must be a registered User and have a User Bitcipher Account on the CoinSwitch Platform.
 - B. You must have successfully completed Know-Your-Customer (“KYC”) verification in compliance with Standard Terms.
 - C. You must maintain a minimum portfolio holding of Crypto equivalent to at least **INR 500 (Indian Rupees Five Hundred Only)** in Your User Bitcipher Account at the time of taking the quiz. The valuation of the portfolio shall be calculated based on the prevailing market price displayed on the CoinSwitch Platform at the exact time of quiz initiation. If You do not meet the aforesaid minimum portfolio holding requirement at the time of taking the quiz, CoinSwitch may verify whether You have held Crypto equivalent to at least INR 500 (Indian Rupees Five Hundred Only) in Your User Bitcipher Account at any time during the preceding one (1) year from the date of attempting the quiz.
 - D. You should be eligible to enter into a binding contracts and Your participation in the Contest should not be prohibited by any Applicable Law
3. **Contest:**
 - A. Eligible participants (“**Participant**”) can enter the Contest via the designated entry banner/option on the homepage of the CoinSwitch Platform. Clicking the entry point will redirect the Participant to the official Contest webpage at <http://coinswitch.co/india-ke-top-1-percent>. If the Participant directly accesses the webpage then the Participant will be directed to open or download the CoinSwitch Platform and complete the eligibility criteria as mentioned above.
 - B. Participants must answer general trivia questions presented on the CoinSwitch Platform. The quiz will be conducted every day and the cumulative score of the week i.e. from Monday to Sunday will lead the leaderboard on the CoinSwitch Platform.

- C. Participants are permitted to attempt the quiz once every day during the Contest Period, provided that the eligibility of the Participant is maintained. At the time of each attempt the Participant must have a minimum of INR 500 worth of Crypto holding in their User Bitcipher Account at the time of each submission or within 1 year from the date of attempting the quiz.
 - D. CoinSwitch shall select top five (5) winners every week from the pool of Participants who have successfully and correctly answered all questions in the quiz in the shortest time duration during that respective week. Time elapsed for answering shall be determined and logged by CoinSwitch's internal systems, which records shall be final, binding, and non-contestable.
 - E. Only the top two (2) weekly winners, comprising the first-place participant and the second-place participant (collectively known as “**Quiz Winners**”) shall be eligible to participate in the audition for the Program, subject to compliance with Clause 5. The remaining three (3) winners (ranking 3rd, 4th, and 5th place) shall each receive Bitcoin (“**BTC**”) worth INR 20,000 (Indian Rupees Twenty Thousand Only) , credited directly into their verified User Bitcipher Account. The valuation of BTC shall be calculated based on the prevailing market price displayed on the CoinSwitch Platform at the exact time of credit, subject to applicable TDS deductions as per Standard Terms.
 - F. The Participant acknowledges and agrees that the answers to the Contest quiz are determined and verified by CoinSwitch. All answers are final and non-contestable. CoinSwitch’s decision in relation to any other matter in relation to the Program and/or the Participant’s participation shall be final and non-contestable.

5. Quiz Winners
- A. Quiz Winners may withdraw their participation from the Contest as per the terms issued by the Producer or broadcaster. Once the participation is withdrawn, the Participant cannot participate in the Contest again.
 - B. Quiz Winners may audition for the Program. Selection as a Quiz Winner does not guarantee participation in the Program. Out of the Quiz Winners who audition, only twelve (12) winners will be selected by the Producer for final participation (“**Final Participants**”) in the Program, based strictly on their evaluation during the audition process. releases, background checks, and documentation/information as required by the Producer from time to time.
